

## Request for Annual and Interim Financial Statements and MD&A

Under National Instrument 51-102 *Continuous Disclosure Obligations* ("NI 51-102"), BeMetals Corp. Notwithstanding whether you have given previous instructions regarding delivery of materials, if you would like to receive the annual or interim financial statements and related MD&A, you should complete and return the Return Form to the Corporation.

Please note that a new Return Form will be mailed each year. This Return Form is a request to receive:

- (i) annual financial statements and MD&A for the fiscal year ending December 31, 2025; and/or
- (ii) interim financial statements and MD&A which the Corporation may send to securityholders in the remainder of 2025 and any other interim period prior to the Corporation sending a new return form.

If you wish to receive copies of financial statements or MD&A for any earlier period, you should send a separate request specifying the requested financial statements and MD&A.
